

# Brain and Mind - Tier 2 Canada Research Chair

The University of Ottawa invites applications for a Tier 2 Canada Research Chair (CRC) in Brain and Mind. The selected candidate will hold a tenure-track position in the Faculty of Medicine, with the potential for a scientific appointment within one of the affiliated research institutes (The Ottawa Hospital Research Institute (OHRI); Children's Hospital of Eastern Ontario Research Institute (CHEO-RI); University of Ottawa Heart Institute (UOHI); Bruyere Research Institute (BRI); Institute of Mental Health Research (IMHR); or The Institute du Savoir Montfort as relevant). The successful candidate will also be an integral member of the University of Ottawa Brain and Mind Research Institute.

We are interested in early career researchers with demonstrated strengths in broad areas of strategic priority for the Brain and Mind Research Institute, including but not limited to:

- Neurodegenerative Diseases
- Neuromuscular Diseases
- Neural Dynamics/Networks
- Acute Injury/Stroke
- Neuropharmacology
- Neuroimmunology

In addition to providing access to a broad range of core facilities and research services, new CRC nominees are also eligible for infrastructure support from the Canada Foundation for Innovation (CFI) to help acquire state-of-the-art equipment essential to their work.

**Tier 2 Chairs:** Tier 2 Chairs, tenable for five years and renewable once, are for exceptional emerging researchers, acknowledged by their peers as having the potential to lead in their field. For each Tier 2 Chair, the institution receives \$100,000 annually for five years.

Candidates should, at a minimum, be Assistant or Associate Professors, or possess the necessary qualifications to be appointed to these levels. Nominating institutions may nominate a professor or a researcher who is more than 10 years from their highest degree at the time of nomination and has experienced legitimate career interruptions (see acceptable justifications). In such cases, institutions must submit to the Secretariat a formal justification (using the Tier 2 Justification Screening Form), explaining why the nominee is still considered to be an emerging scholar. The University recognizes the legitimate impact that leaves (e.g., parental leave, leave due to illness) can have on a candidate's record of research achievement and that these leaves will be taken into careful consideration during the assessment process.

**Preferential Hiring:** The University of Ottawa strongly supports a workplace environment that removes disparities experienced by the designated groups in Canada: women, Indigenous peoples, persons with disabilities and members of visible minorities, as defined in the Employment Equity Act. This competition is a preferential hiring, which gives priority to one or more of the designated groups.

Candidates from these groups who wish to qualify for preferential consideration must fill the self-identification form.

**Required Qualifications:** A PhD or equivalent, superior research achievements in the CRC's identified area(s) and proof of interdisciplinary collaborations, a solid record with respect to teaching and training of students at the graduate level, the ability to obtain external research funds, excellent communication skills in either English or French. A passive knowledge of the other official language is considered an asset.

Rank and salary: Regular tenure-track academic appointment in the Faculty of Medicine. This position is governed by a collective agreement between the University of Ottawa and the Association of Professors of the University of Ottawa.

Application Package:

- A cover letter;
- An up-to-date curriculum vitae (please include career interruptions such as parental or sick leaves that may have impacted your record of research. These will be taken into consideration in the selection process);
- A research plan (2 to 3 pages);
- A statement of teaching interests (1 to 2 pages); and
- The names of three people who may be contacted by the University for letters of reference.

**Deadline:** March 8<sup>th</sup> 2019

The selection process will begin in March and will continue until the position is filled. Only candidates selected for an interview will be contacted. Please send the application package to the following address or by email to:
